## BOARD MATTERS

- \* **CONGRATULATIONS** on a really productive third quarter, which ended Sept. 30. We've gotten a tremendous amount of good education and service done and want to thank everyone for their hard work and dedication.

- \* **Staffing adjustments** starting now and through 2019

### Secretarial activities

- KIM WOOD will continue to reserve space for training classes and booth space for festivals. She will also schedule volunteers for festivals.
- CHRIS DISSER will continue to take registrations for service projects and send out confirmations / project details.
- DONNA will continue to send recruitment emails for education and service events; she will also take registrations for training classes and send confirmations / class details.

### Treatment projects

- BOB PLEDGER will continue to coordinate treatment projects in the eastern counties.
- DAVID & CINDY WASILESKI will begin coordinating treatment projects in the western counties, with logistical support from Donna and Bob.
- FRANK AND LINDA GHEESLING will continue providing team leadership whenever possible.
- DARRELL SHEFFIELD has a very busy year coming up but will help with treatment projects and festivals as his travel schedule allows.
- DERRICK MORRIS has volunteered to coordinate a large neighborhood treatment project next year.

### Saplings projects

- BUZ STONE will continue to coordinate saplings projects in the eastern counties.
- CHRIS CURTIN will continue to coordinate saplings projects in the western counties.
- JOHN SHEAROUSE will continue as saplings technical advisor and will be starting a new hemlock section at his nursery in Lavonia.

### \* **Special recognition for Eagle Scout projects**

Allen Hughes and his troop, assisted by BOB PLEDGER and BUZ STONE, did a hemlock treatment project on 12-2-17 to treat 29 large old hemlocks in the historic cemetery in Clarkesville.

Everett Reynolds and his troop, assisted by BUZ STONE, did a hemlock sapling rescue / potting project on 9-29-18 to save 70 little trees from a private property in Rabun County.

### \* **Canceled or postponed events in 2018**

### \* **Lessons learned in 2018**

- We need a handout to attract volunteers, explaining the importance and rewards of volunteering and the kinds of educational / service opportunities available through SGH.
- We should have a schedule of training classes and service projects to use at festivals for getting folks signed up on the spot.
- We should have a volunteer walking around the festivals carrying a hemlock sapling and directing people to our booth.
- We need a simplified handout for treating hemlocks.
- We should continue recruiting younger members for our Leadership Team to address our growing scope of educational / service initiatives and to ensure continuity.
- We need a document for Eagle Scout projects explaining the process for partnering with SGH, responsibilities of the Scout and his troop, and responsibilities of SGH. ELLIOTT SEGALL has offered to help with this.

\* **Neighborhood hemlock treatment project** in cabins area at Lake Winfield Scott – Asking DERRICK MORRIS to coordinate this.

\* **Cartecay Tract** hemlock treatment project – As we have no coordinator for this extended project and many other commitments competing for volunteers / time, the group decided we will not continue this one. So we will give the chemical on hand either to Mountain Stewards if they plan to continue to project or to one of the DNR divisions we work with (Wildlife Management or State Parks). DONNA will contact DNR and Mountain Stewards about this.

\* **Annual Hike & Help the Hemlocks** – We were not able to do this event in 2018 because of scheduling difficulties on the part of all organizations involved, but our group wants to do it again in 2019. As always, it will be a joint event with the Benton MacKaye Trail Association, and it would be great to include Trout Unlimited again and the Mountain Stewards too. The group suggested we schedule it for a regular BMTA work day during the week in Sept of Oct. The swinging bridge on the Benton MacKaye Trail was recommended as a possible location. DONNA will contact BMTA, TU and MS.
